

New State of Michigan Graduated License Process

(as of 3.16.21)

• Once the student completes and passes the Segment 1 course (all 24 hours of classroom, 4 observations, and 6 behind the wheel hours) our Compliance department will enter the student's completion information into the State's website and download a completion certificate. This certificate is e-mailed to the customer within 5 business days of completion from our team. The student will visit a local SOS branch office with all required documents, a photo will be taken, they will pay a \$25 driver's license fee, and a hard card GDL Level 1 license will be issued from the SOS and mailed to your home within 60 days. The student will leave the SOS office with a permit receipt which can be utilized until your hard card comes in the mail.

Level 1 License Restrictions

- Teens with a Level 1 license may only drive with a licensed parent/guardian or designated licensed adult age 21 or older.
- Once the student passes the Segment 2 course (all 6 hours of classroom and the final exam) our Compliance department will enter the student's completion information into the State's website and download a completion certificate. This certificate is e-mailed to the student within 5 business days of completion from our team.
- Once the student has passed the driving skills test (road test) the driver testing provider will enter their information into the State's website. The information is updated the next business day at 8:00 am. Once the student has completed Segment 2, passed the driving skills test, and turned 16 years old they will automatically be upgraded to a GDL level 2 license. This will be mailed to the customer within 60 days from the SOS office.

*If your original level 1 license was issued before March 16th, 2021, you will need to return to a local SOS office to apply for a level 2 license.

Level 2 License Restrictions

- Prohibited from using a cell phone while driving.
- Cannot drive between 10pm and 5am except for employment, an authorized activity (school event, vocational training, sporting event, religious event, or emergency), or accompanied by a parent or legal guardian 21 years old or older.
- Cannot drive with more than 1 passenger who is younger than 21 years old except when its immediate family members, going to or from employment, an authorized activity, or accompanied by a parent or legal guardian 21 years old or older.

- Once the individual turns 17 years old, has held their level 2 license for at least 6 months, and completed 12 consecutive months without a moving violation, a crash, a license suspension, or a violation of the GLD license, they will automatically graduate to a GDL level 3 license. This license is automatically issued at no fee, provided all requirements are met and parental authorization was granted. This will be mailed to the customer within 60 days.
 - o If you do not want your teen to automatically advance to a Level 3 License, you must complete the Parent/Guardian Request to Continue Minor's Level 2 Intermediate License form. This form (BFS-146) is available at your local Secretary of State branch office or at Michigan.gov/TeenDriver.

o Level 3 License Restrictions

- Teens with a Level 3 license have no state-imposed license restrictions.
- If the individual has progressed to a GDL level 2 license or GDL level 3 license by their 18th birthday, a new operator's license will be automatically issued and mailed to the individual. The individual can log into e-Services to obtain a temporary license while they wait for the new license.
 - o If the individual never progressed past the GDL Level 1 license, they would need to visit a branch and follow the standard process for obtaining a driver license.

IMPORTANT INSTRUCTIONS

If you passed a Driving Skills test, you do not need to return to a Secretary of State branch office to obtain your new driver's license, the new photo license will be mailed to you. The skills test results will be reported electronically to the Department of State. Once your skills test results are reported, you will be able to obtain a Temporary Operator License through e-Services. You should get an email confirmation (if an email was provided) when they have entered your results The Driver Testing Business should have your skills test results electronically reported to the Secretary of State by 11 pm on the day of your driving skills test; however they will not be posted until 8 am the following business day.

Instructions on obtaining your Temporary Operator License:

- 1. Go online to https://dsvsesvc.sos.state.mi.us/TAP/ and select "More Driver Services".
- 2. You will be redirected to MILogin. If you already have a MILogin account, log in. If you do not have a MILogin account, follow the prompts to sign up.
- 3. If you are logging in for the first time, you will be authenticating with the following information to get access to CARS e-Services.
 - a. First and Last name
 - b. ID Number (Driver's License Number or State Identification Number)
 - c. Date of Birth
 - d. Last Four of SSN
- 4. Once you have accessed your e-Services account, you should have an alert that you have a Temporary Operator License that is available to be printed.
- 5. Follow the prompts to print your Temporary Operator License.
