**Affirmation of Eligibility:** By registering for this course, I affirm that I am eligible to attend a defensive driving course to dismiss an eligible citation. I acknowledge the following; I have not taken a defensive driving course within the past 12 months, I have verified with the court of jurisdiction that I am eligible to take this course, I was not involved in a serious injury or fatal accident (as defined in ARS 13-105.34), and I do not hold a Commercial Driver's License (or if I do, I acknowledge this course does not recognize any CDL citations, and will not be recognized through this course).

**Refund Policy:** ALL refund requests for all services offered are charged a \$5 processing fee. No refunds are permitted for any course required by the court or as a result of a citation, REGARDLESS of how much of the course has been completed. Refunds take 2-3 weeks to process and will be in the form of a check. No refund will be issued if the student is expelled due to disciplinary reasons. Upon failure to complete the course within the required time frame, no refund will be granted and no certificate will be issued.

**Reason for Possible Denial:** You may be denied at any time for enrollment to this course for any of the following reasons; if you do not meet the minimum eligibility requirements for the state of Arizona, if a student is found cheating, or if another student is caught taking the course for the registered student.

**Requirements to Pass Driver Education:** As a student, you will be required to participate in all 4 hours of online instruction, including all Modules and activities throughout the course. You will also be expected to pass the final examination at the end of the course with an 80% or higher. If these terms are not met, no certificate of completion will be issued.
