All Star Driver Education, Inc. shall provide at least 8 hours of behind-the-wheel training based on the Ohio Driver Training Curriculum. The student will complete the 24 hour equivalent of required classroom with an Ohio approved online provider. **The student must provide a certificate of enrollment in an approved online driver education program to begin the eight hours of behind-the-wheel training.** Should a student be unable to attend available training sessions offered, the school is relieved of the aforementioned obligation. All Star Driver Education will conduct the behind-the-wheel instruction in a dual controlled automobile, fully insured, covering each student enrolled in the program. The school will provide the licensed instructor, vehicle, and fuel for the driving instruction.

Any additional in-car training may be obtained at the hourly rate of \$ 60.00 per hour. If applicable, the Student may, for an additional fee of \$ 50.00, use our All Star Driver Education's vehicle to take a driving exam at a State exam center located in \_\_\_\_\_ County, OH.

The Student is required to obtain a valid temporary driving permit and pay tuition in full prior to scheduling the practical driving portion of the training. If the student must cancel a scheduled driving appointment, cancellation must be made a minimum of 48 hours prior to the scheduled appointment. Failure to do so may result in an additional fee of \$ 20.00 per scheduled drive hour. The same fee shall apply should the Student fail to appear for, or for any reason not prepared to take, the scheduled lesson.

The student is required to complete all available training within six months of the date the training begins. No student is permitted to complete more than four hours of online and behind-the-wheel training in a twenty-four hour period. All Star Driver Education must make available any remaining behind-the-wheel training once the student provided proof of completion of an online driver education program. There may be no refunds provided after that time. Upon expiration of this agreement, a reinstatement fee may be charged before any further services are provided. All Star Driver Education does not guarantee the issuance of a driver license to the Student. If training is not completed within the six months, a new agreement shall be established and training shall be restarted.

All Star Driver Education reserves the right to cancel this agreement at any time, should the Student's conduct indicate a lack of responsibility deemed necessary by All Star Driver Education to safely operate a motor vehicle. Destruction of property, or the possession, distribution, or use of any tobacco product, alcohol, or drug of abuse is strictly prohibited. Should this agreement be cancelled under such circumstances, all fees may be pro-rated, based upon hours of service provided prior to cancellation.

**Refund Policy:** ALL refund requests for all services offered are charged a \$5 processing fee. No refunds are permitted once a student has participated in one or more drive hours. Refunds will be processed in full if a class/service is cancelled by ASDE. Refunds take 7-10 business day to process and will be returned to the original payment card. No refund will be issued if the student is expelled due to disciplinary reasons. To learn more about our discipline policy, please visit the FAQ's on our website, or contact our Corporate Office. There will be a \$30 return check fee for all returned checks! Upon failure to complete the course within 180 days of starting the course, no refund will be granted and no certificate will be issued.

**Parental Permission for Driver Education Instruction:** I hereby give consent for my son/daughter, as stated above, to take a complete course of Driver's Education which includes the eight hours of behind the wheel instruction listed in this contract. This course is conducted under the supervision of a state licensed instructor. I have read and understand the above policies and procedures for my child to take part in this program provided by All Star Driver Education, Inc.

**Certificate of Completion:** Due to the process of ensuring that every student has received the correct amount and content of instruction, as well as recording the details of the instruction, it may take up to 2 weeks to receive a certificate by mail after completing the course requirements. It is not recommended to schedule a road test before receiving the completion certificate. It is prohibited by the State of Ohio for any driving school to send a certificate via e-mail or fax. Rush mail is available for an additional fee. If a Certificate of Completion is misplaced or destroyed, there is a \$15 fee to replace it.
